NEW THIS YEAR: Vendors received before **JULY 1st** will be published in the 2011 Festival Program, which will be distributed to over 23,000 homes in Hilliard.

Rules, Terms and Conditions of Participation for Vendors

There are a limited number of spaces available. They will be reserved on a first-come, first paid in full basis. The Hilliard Civic Association reserves the right to refuse an application if a vendor with essentially the same products has already applied and paid in full. This agreement must be completed, signed and received with payment by August 27th 2011. Any applications received after August 27th, 2011 is subject to a \$10.00 late fee. Fees are non-refundable after August 15th, 2011, including if the event is cancelled due to weather.

Booth confirmation letters and event maps/directions will be sent after August 27th, 2011.

Booth Setup and dismantle

Booth setup begins Saturday from 7:00 a.m. to 9:00 a.m. and must be completed by 9:00 a.m. Other vendors may fill booths not occupied by 9:00 a.m. Your booth must be completely removed by Saturday at 7:00 p.m.

Upon arrival, vendors must **STOP** and show **CONFIRMATION LETTER** to the traffic control person to check in and receive further instructions for set up and parking.

Vendors will receive one parking pass per vending location to park in a designated area near the Festival. All other vehicles will need to be parked in Festival general parking.

Vendors **MUST NOT DISMANTLE** booths or exhibits while Festival is in operation. **DISMANTLE TIME** begins on Saturday at 5:00 p.m. and booths and exhibits must be **COMPLETELY DISMANTLED AND OFF THE STREET BY** Saturday at 7:00 p.m. **ANY VENDOR WHO PULLS OUT EARLY WILL NOT BE INVITED TO RETURN TO FUTURE FESTIVALS.**

Vendor's materials – including tables, chairs, lights, tents, 3-prong UL listed outdoor extension cords etc. are to be supplied by the vendor.

Required Portable Fire Extinguisher

According to the Ohio Fire Section 906.1,

ALL vendors with tents, canopies and membrane structures must have a minimum, 2-½ lb. A.B.C. Portable Fire extinguisher.

Norwich Township Fire Dept. will enforce this Ohio Fire Code for everyone's safety.

YOUR TENT WILL BE INSPECTED FOR A FIRE EXTINGUISHER.

Electrical Connections

For your safety, Under NO CIRCUMSTANCES may a vendor make any connections to and/or have any contact with the electrical generators on site.

Electrical services are provided solely for the convenience of VENDOR without warranty and/or representations. VENDOR specifically acknowledges and agrees that Old Hilliardfest shall have no liability for any claims whatsoever relating the to the provision of electrical power or for any failure to provide electrical power.

Vendor shall be permitted to use only electrical service of the nature and amount as approved by The Old Hilliardfest.

Wind Damage

To avoid wind and personal/property damage, the Old Hilliardfest strongly suggests stakes or 50lbs. weights attached to your tent.

Insurance Requirements

All VENDORS serving food must secure and maintain commercial general liability insurance on an "occurrence" basis with liability limits in the amounts of \$1,000,000.00 per occurrence covering personal injury, bodily injury and property damage; list as additional insured the Old Hilliardfest. VENDOR is also responsible for obtaining Certificates of Insurance for any and all subcontractors hired by VENDOR
